

**RESOLUTION NO. 2016-1-13-8**

**RESOLUTION OF THE PARKING AUTHORITY OF THE TOWNSHIP OF BLOOMFIELD APPROVING A SALARY INCREASE FOR THE AUTHORITY'S METER MAINTENANCE SUPERVISOR**

**WHEREAS**, the Parking Authority of the Township of Bloomfield (the "Authority"), a public body corporate and politic of the State of New Jersey (the "State"), was created by the Township of Bloomfield Council in accordance with the Parking Authority Law, P.L. 1948, c. 198, N.J.S.A. 40:11A-1 *et seq.*; and

**WHEREAS**, the Authority desires to adjust the salaries of its employees as set forth herein; and

**WHEREAS**, the Authority further desires to set a minimum salary to be paid to any employee of the Authority; and

**WHEREAS**, the aforementioned salary adjustments shall be retroactive to take effect as of January 1, 2016.

**NOW, THEREFORE, BE IT RESOLVED** by the Authority as follows:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.
2. The salaries of the employees referenced below shall be adjusted as set forth below:
