

**RESOLUTION NO. 2016-2-10-4**

**RESOLUTION OF THE PARKING AUTHORITY OF THE TOWNSHIP OF BLOOMFIELD REMOVING FORMER COMMISSIONERS OF THE AUTHORITY AS SIGNATORIES ON THE AUTHORITY'S DEPOSITORY ACCOUNTS WITH PROVIDENT BANK**

**WHEREAS**, the Parking Authority of the Township of Bloomfield (the "Authority"), a public body corporate and politic of the State of New Jersey, was created pursuant to the Parking Authorities Law, N.J.S.A. 40:11A-1 et seq (the "Law") for the purpose of constructing, providing for and/or operating off-street and on-street parking projects within the Township of Bloomfield, New Jersey (the "Township") in order to promote free movement of traffic and relief of traffic congestion on the streets of the Township and to improve conditions affecting the public safety and welfare therein; and

**WHEREAS**, pursuant to Resolution No. 2016-1-13-4, the Authority designated The Provident Bank as an official bank depository (the "Provident Bank") for the Authority; and

**WHEREAS**, in order to operate efficiently the Authority determined that it was necessary to maintain multiple signatories on its accounts with the Provident Bank; and

**WHEREAS**, due to the change in membership of the Commissioners of the Authority, the authorized persons listed on the signer cards for the Authority's Provident Bank accounts requires updating and former Commissioners of the Authority should be removed as signatories on its Provident Bank accounts.

**NOW, THEREFORE, BE IT RESOLVED** by the Bloomfield Parking Authority as follows:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.
2. The Executive Director of the Authority is hereby authorized and directed to remove Abdallah Chalet and Yudi Sobharam as signatories on the Authority's Provident Bank accounts and to execute and submit all necessary papers and documentation to effectuate such removal.
3. This resolution shall take effect immediately.


