

**RESOLUTION NO. 2015-3-11-1**

**RESOLUTION OF THE PARKING AUTHORITY OF THE TOWNSHIP  
OF BLOOMFIELD AMENDING AND RESTATING BY-LAWS**

**WHEREAS**, the Parking Authority of the Township of Bloomfield (the "Authority"), a public body corporate and politic of the State of New Jersey, was created pursuant to the Parking Authorities Law, N.J.S.A. 40:11A-1 *et seq.* (the "Parking Law") for the purpose of constructing, providing for and/or operating off-street and on-street parking projects within the Township of Bloomfield, New Jersey (the "Township") in order to promote free movement of traffic and relief of traffic congestion on the streets of the Township and to improve conditions affecting the public safety and welfare therein; and

**WHEREAS**, the Authority desires to further amend and restate in their entirety its by-laws, as the same were duly adopted by Resolution No. 2004-1-15-1, as amended by Resolution No. 2004-4-20-1, Resolution No. 2004-7-20-4, Resolution 2004-10-19-3 and Resolution 2013-6-27-2 (collectively, the "By-laws"); and

**WHEREAS**, said amended and restated By-Laws, entitled "Amended and Restated By-Laws of the Parking Authority of the Township of Bloomfield" (the "Amended and Restated By-laws"), are attached hereto as **Exhibit A**.

**NOW, THEREFORE, BE IT RESOLVED** by the Authority as follows:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.
2. The Authority hereby adopts the Amended and Restated By-laws.
3. A copy of this resolution shall be available for public inspection at the offices of the Authority.
4. This resolution shall take effect immediately.
