

RESOLUTION NO. 2014-12-10-5

RESOLUTION OF THE PARKING AUTHORITY OF THE TOWNSHIP OF BLOOMFIELD APPROVING PURCHASE OF OPERATING EQUIPMENT

WHEREAS, the Township Council of the Township of Bloomfield (the "Township"), pursuant to Ordinance 03-27 (the "Creation Ordinance") duly adopted August 4, 2003 and the Parking Authority Law of the State of New Jersey (the "State"), N.J.S.A. 40A:11A-1 et seq., as amended and supplemented (the "Act"), created and established the Parking Authority of the Township of Bloomfield (the "Authority") as a public body corporate and politic of the State and an agency of the Township with all the powers, privileges, and authority conferred by the Creation Ordinance and the Act including, but not limited to the management and operation of all parking meters and related facilities located within the Township; and

WHEREAS, the Authority believes that it is in its best interests to acquire a Phone-Based Intercom System for the Lackawanna Parking Garage and additional proximity cards, which will allow permit-holders to access the Lackawanna Parking Garage; and

WHEREAS, the Authority obtained a proposal, dated September 26, 2014 from Precision Technology Solutions, 289 North Main Street, Ambler, PA 19002 ("Precision"), to provide the aforementioned operating equipment; and

WHEREAS, the Authority desires to approve the purchase, from Precision of such equipment, and to authorize any of the Commissioners of the Authority and/or the Executive Director (each an "Authorized Officer") to take any and all actions necessary to implement this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Authority as follows:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.
2. The Authority hereby approves the purchase, from Precision, of a Phone-Based Intercom System for \$5,558.36 and 200 Proximity Access Cards for \$650.00 in accordance with the September 26, 2014 proposal from Precision.
3. Any Authorized Officer is hereby authorized to take any and all actions necessary to execute and implement this resolution.
4. This resolution shall take effect immediately.

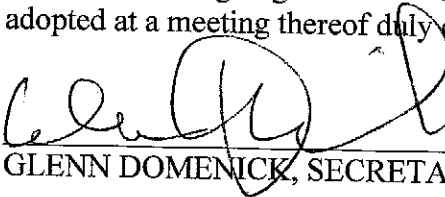
